- TERI Inc. grants permission to to display the Artworks at no rent or charge, at the TERI Campus of Life located at the following address: 555 Deer Springs Rd San Marcos, CA 92069
- TERI does encourage and request a donation in good faith for a percentage of total revenue, suggested 10% donation at culmination of show.
- TERI Inc. agrees to permit Artist to enter the premises during business hours with the purpose of promoting and/or selling Artwork to prospective customers and will inform the primary contact of visitations with a minimum of 48 hours advanced notice.
- Any installing or removing of artworks will be arranged as not to interfere with regular business customers.
- 2D work should be ready to securely hang on a flat slat wall metal utility hook. 3D work should be under 2lbs and mounted with Museum Putty.
- Display of art shall be subject to approval of TERI, Inc. Submit photos and inventory to include size, medium and price. This information will be utilized to create TERI branded information cards. Attach images via email saved in the following format: Title_Medium_Size_ArtistName_Price.jpg
- An inventory sheet describing the art, size, price, condition and entrance/exit/sales of artwork on display will be due to TERI Inc. by the Artist.
- Artist will supply brief artist bio & statement to include any links to portfolio. TERI will utilize this to create Artist Statement and Introduction poster. Artist agrees to photo relase of Artwork for promotional purposes.
- Sold Artwork may be removed at the time of sale and replaced within 72 hours by the artist. TERI's Primary Contact will reach out to artist to inform Artist of any such sold works.
- Sales from the artwork shall be managed by the artist via remote payment systems like Venmo, PayPal, or Zelle. Artist will need to provide working link for QR Code and independently oversee all sales.
- TERI Inc. will not be responsible for accidental damage or theft.
- This agreement goes into effect with the installation of the Gallery Wall Display and can be terminated at will by either party. Upon termination, Artist will promptly remove the artwork from TERI Inc. premises.
- 100% of actual sales of any displayed wall art goes to the artist.
- Artwork is shown on a quarterly rotation, after approval artist will be added to the exhibit calendar. Work will need to be hung the last week of the month.
- Incomplete packets will not be considered.

- ☐ • Reminder, Upon end of show or termination, Artist will promptly remove the artwork from TERI Inc. premises.
- ☐ • Reminder, 100% of actual sales of any displayed wall art goes to the artist.
- ☐ • Reminder, art is exhibited quarterly, and should be placed and taken down the last week of the month for the period.
